POSTPONEMENT OF THE NEW TAKAFUL BASIC EXAMINATION (TBE) IMPLEMENTATION AT ISLAMIC BANKING AND FINANCE INSTITUTE MALAYSIA SDN. BHD. (IBFIM)

We refer to the above matter and the recent announcements by IBFIM and the Malaysian Insurance Institute (MII) about the TBE implementation.

Please be informed that the new Takaful Basic Examination (TBE) implementation, which is supposedly administered by IBFIM starting 3 January 2012, has been postponed to **1st April 2012**. The main reason of the postponement is to allow adequate time for dissemination of information of the new policies and procedures for the new TBE. The relevant dissemination of the new TBE implementation will be made soon.

In line with the postponement, MII will re-administer the TBE starting January 2012 to March 2012 and the schedule for TBE this period is attached in **Appendix 1**. During this extension period of 3 months, the compulsory requirement to purchase "***Buku Asas Panduan Takaful***" for the TBE sittings is also being uplifted to allow MTA member companies to reduce their respective stock of the existing TBE books. The TBE registration form will be given free to all TBE candidates.

Please be informed accordingly and kindly disseminate the information above to the relevant departments in your organization.
