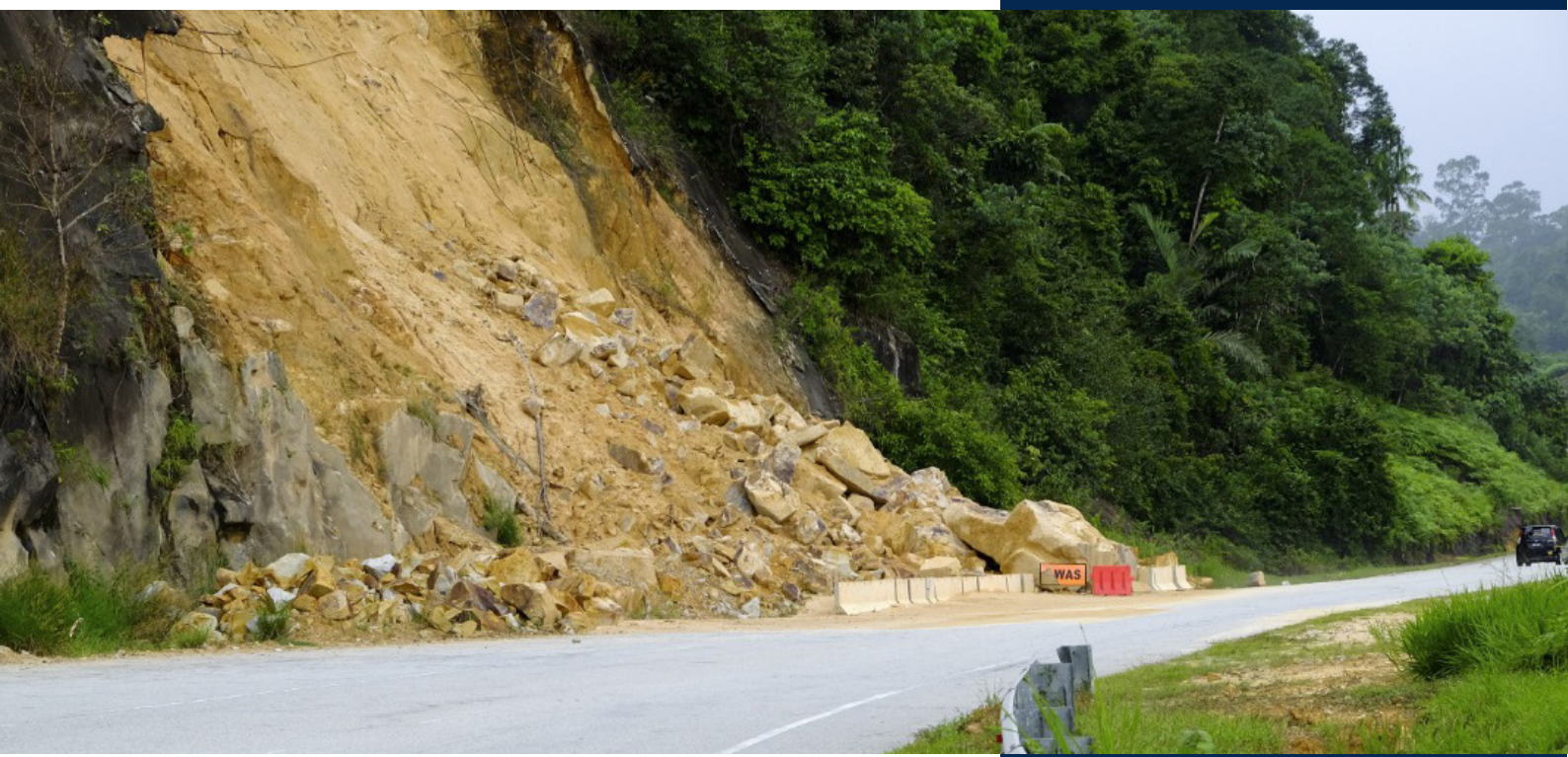
A guest speaker is invited to present a specialist topic related to this coverage.
